- b. Information of all College Teachers shall be updated on the University Academic Online Teachers Database & monthly review shall be taken by College Coordinator so as to ensure that teacher's information is regularly updated.
- c. Those UG/PG qualifications that are not yet recognized by the Central Govt. it is mandatory for the college to apply to the Central Council through Central Govt. and ensure that Permitted/Not Recognized qualifications are enlisted in "Recognized Qualifications", failing which University shall not grant Continuation of Affiliation to such courses from ensuing Academic Year & no student shall be admitted in such courses.

2. You are requested to comply with the above mentioned deficiencies within the stipulated time without fail and submit compliance report.

Important Note:

- 1) The Continuation / Extension of Affiliation is issued for the Academic Year 2021-2022 subject to the permission of Central Council of Ayurved and Unani, New Delhi/Govt. of India/Department of AYUSH, New Delhi and if the permission is declined by the said authorities this Continuation / Extension of Affiliation will be treated as cancelled. The college is not authorized to admit the students for 1st year of the course until receipt of permission of the Central Council of Ayurved and Unani, New Delhi/Govt. of India/Department of AYUSH, New Delhi.
- 2) The admission shall be done only through the Competent Authorities.
